

## Decision

### Article 1

The visiting supporters of AEK Athene may solely use on Tuesday 22 august 2023 the approved transportation by coach under the known combination scheme, via the set meeting point en route Park Spoor Oost in Antwerp, and in particular to and from Bosuil Stadium at 54a, Oude Bosuilbaan in 2100 Deurne (Belgium).

Only those coaches that display an official coach vignette, issued by the Antwerp Police District, will be admitted to the city.

The number of chartered coaches is limited to 17 coaches for supporters. Harmonica buses are not allowed.

In practice, visiting supporters will only be allowed to board the coaches on condition that they can present a valid voucher to the RAFC – AEK Athene football match on Tuesday 22 august 2023 and proof of ID. AEK Athene must verify this in advance. After these checks, the voucher will be exchanged for a valid ticket for the football match RAFC – AEK Athene on 22 august 2023.

The coaches must then follow the route indicated to them by the police to a closed car park, which connects to Bosuil Stadium. Upon arrival at the stadium, each supporter must undergo the same verification process again, to be performed again by AEK Athene, under the supervision of RAFC.

After the match, the visiting supporters must use these coaches again to leave from Bosuil Stadium. They will also be accompanied by police for part of the return journey.

### Article 2

Sales of tickets to the match of Tuesday 22 august 2023 will be limited as follows:

- pre-sales of tickets may only be organised by RAFC, at its ticket office or online;
- resale of tickets is only allowed through the “free your seat” system set up by the club. The new ticket holder is also registered and checked on the basis of his identity card;
- the ticket offices of Royal Antwerp Football Club must remain closed on Tuesday 22 august 2023. On this date, no tickets may be sold at the ticket offices, nor may these be offered for sale online.
- the tickets may be distributed according to the one-to-one principle:
  - one ticket per person at the ticket office, upon presentation of an ID card and after full registration in a ONE account (registration of the electronic identity card and passport photo);
  - one ticket per fully registered ONE account;

- season ticket holders must preorder a ticket from RAFC within the priority period, as season tickets cannot be used for this match;
- Commercial partners or groups that are invited must submit a list of names of the individuals who will attend the match by Monday 21 august 2023 at 12.00hrs. They can only obtain tickets for these individuals. The division between supporters must also be strictly adhered to in this case. The commercial partners hold ultimate responsibility for the persons to whom they distribute tickets.
- No category 1 tickets may be sold in tribune 1 to supporters of the visiting team AEK Athene.

### **Article 3**

Subject to the application of Article 1, a restriction perimeter will be enforced for all supporters of AEK Athene on Monday 21 august 2023 from 00.00 hrs until Wednesday 23 august 2023 at 02.00 hrs.

The restriction perimeter applies within the following area, that is delineated by the following streets, including these streets, insofar as they are part of the territory of the City of Antwerp:

Schijnpoortweg (ter hoogte van de Lange Lobroekstraat) – Park Spoor Oost (inclusief) – Buurtspoorweglei – N10 Noordersingel/N12 Turnhoutsebaan tot aan Houtlaan (Wijnegem) - Houtlaan - Ertbruggestraat - Ertbruggelaan - Schotensesteenweg - Muggepad - Deurnesteenweg - door de wei tussen Wokpaleis en Benzinstation Gabriëls - Merksemsebaan (N120) - Industrielaan (tot firma Geodis) – Bisschoppenhoflaan – Kruiningenstraat – Melkerijstraat – Middelmolenlaan – Santvoortbeeklaan – Belcrownlaan – Merksemsesteenweg – Vaartdijk – Burgemeester Gabriël Theunisbrug - - Schijnpoortweg (ter hoogte van Lange Lobroekstraat).

Visiting supporters who are in possession of a valid voucher for the football match RAFC – AEK Athene on 22 august 2023 will only be admitted within the aforementioned perimeter on Tuesday 22 august 2023 from 18.00 hrs and only at the rendezvous point at Park Spoor Oost.

Persons who have a valid reason for being within this restriction perimeter during Monday 21 august 2023, Tuesday 22 august 2023 and Wednesday 23 august 2023 (among others because this is their main place of residence), do not fall under the provisions of Article 3.

### **Article 4**

Without prejudice to the legal publication, the Mayor orders the Antwerp Police District to inform the following parties of this police regulation:

- NV Royal Antwerp Football Club, Oude Bosuilbaan 54A, 2100 Deurne (Belgium);
- Athlitiki Enosis Konstantinoupoleos, Kappadokias & Attalias, 14341 Nea Filadelfeia (OPAP ARENA).

## **Article 5**

The notified football clubs are obligated to inform their supporters of this temporary police regulation and take the necessary measures to ensure the safety measures they must provide for are in place.

## **Article 6**

This police regulation takes effect immediately after publication.

## **Article 7**

Failure to comply with this temporary police regulation will be punished with the administrative sanctions provided for in Article 4 §1.1 of the Act of 24 June 2013 on municipal administrative sanctions.
